Design Team Report and Discussion – Lisa Radosevich-Craig and Paul Danicic

Paul Danicic and Lisa Radosevich Craig gave an overview of the plans for the 2011 International Community Congress, and the status of the Design Team, which is planning the event. After the presentation by Lisa and Paul, participants worked in small groups with the task of identifying who from their community should be invited/asked to participate in the *International Community Congress* itself. Each group reported out ideas.

-----Summary of the Progress-----

Building on the experience of International Falls and Voyageurs National Park, a group of four people from HOCP went to the *Balancing Nature and Commerce* workshop to determine if this model would work for the Heart of the Continent gateway communities. The unanimous reply was yes.

The workshop, planned for fall of 2011, has been named the *HOCP International Community Congress*. HOCP will support and host this workshop as a neutral ground where a diverse mix of community leaders and public land managers, from gateway communities around the region, can come together and create local action plans that benefit both the community's economy and the health of the public lands (in keeping with the HOCP concept).

A Design Team has been assembled which will plan, prepare for and host the planned 2011 workshop. Current Design Team members are:

Presentations

Grand Portage Band (Norm Deschampe, Tribal Chair)

Norman gave the group some of the history and current overview of the band, followed by questions.

The band has 1200 band members; two marinas, casino & lodge, and recently purchased a resort that will be renovated

Grand Portage National Monument (GPNM) exists because the land was donated by the tribe. One component of the legislation was to provide employment for tribe members. The maintenance department at GPNM is run by the tribe and all employees are band members. The new High Falls State Park is also operated in this manner.

Science Committee Update (*Brian McLaren, Lakehead University*)

Brian gave a report on the recent activities of the committee, followed by a few questions. The committee has discussed themes by which to evaluate project proposals HOCP might support:

- study of ecological function on the landscape
- study of how people interact in the region: in spiritual, cultural, recreational, economic and ecological ways
- incorporation of education, community outreach, and citizen science
- study that tracks environmental change, social change or economic restructuring
- comparisons of processes or ecosystems in areas where natural disturbances are managed to the same processes or ecosystems in areas where extensive human disturbance occurs, i.e. from extractive industry

Boreal Forest Resilience Project (*Sarah Crow –Program Coordinator*) Sarah presented an update of this research, which is headed up by Peter Reich of the University of Minnesota.

1. primary objective is to promote resilience – a community and ecosystem as a whole responding/reorganizing sustainably
2. Four primary components
 - a. partnerships
 - b. research - slow and fast drivers in the region; ecosystem services
 - c. scenario studies
 - d. adaptive landscape management planning
3. funded by the University of Minnesota’s Institute on the Environment

Rivers & Trails Conservation Association (*Holly Larson, Outdoor Recreation Planner*)

RTCA helps communities with projects that will end up with something on the ground like a bike trail or conservation area. Their assistance comes in the form of staff time, providing planning expertise. Mission is to focus on new facilities and new conservation areas. Could perhaps assist with planning for any recreational facilities that the come out of the International Community Congress action plans
